

On February 10, 2011, a vehicle operated by MI BUSINESS INCORPORATED, and driven by DEAN M MCMASTER, was inspected within the State of Ohio. As the result of discovery of the following apparent violation the Staff timely notified Respondent pursuant to Rule 4901:2-7-07, O.A.C., that it intended to make a civil monetary assessment against Respondent in the following amount:
