



OneCommunity is 501(c)3 nonprofit organization with the mission to expand the use of highspeed broadband access and adoption to enhance the global competitiveness of Northeast Ohio. Through a combination of private foundation grants and Federal construction grants of over \$70 million, OneCommunity is building a community fiber network. This network will connect more than 1500 community anchor institutions such as hospitals, physician clinics, universities, K-12 schools, government entities, public safety agencies and nonprofit organizations.
