Dear Ms. McCauley:

The Commission issued its Finding and Order in the above-referenced proceeding on June 29, 2011. In the Finding and Order, the Commission adopted an unopposed joint stipulation and recommendation that provided, *inter alia*, that KNG Energy, Inc. ("KNG"), Ohio Gas Company ("Ohio Gas"), and the Village of Deshler, Ohio would assume the obligation to provide natural gas service to the customers of Suburban Natural Gas Company ("Suburban") affected by its application to abandon service.

Paragraph 20 of the Finding and Order provided as follows:

- (20) Finally, Suburban should file a revised tariff that removes from its service territory the villages of Hoytville, Deshler, Hamler, Malinta, and Holgate, Ohio, as well as the customers located in the unincorporated areas in the vicinity of the villages, as identified in the application filed in this case. In addition, Ohio Gas and KNG should file revised tariffs that incorporate those portions of Suburban's territory for which they will be providing service, as set forth in this case.

The purpose of this letter is to advise the Commission that KNG's current tariff, P.U.C.O. No. 1, applies to all jurisdictional service rendered by KNG and does not differentiate by either geographic area or political subdivision. Thus, there is no need for KNG to revise its current tariff to accommodate the service arrangements approved in the Finding and Order. In addition, KNG notes that, pursuant to the terms of the joint stipulation and recommendation, KNG will serve all the former Suburban customers transferred to KNG at the same rates it serves its


