OPSB members and staff,

The safe setback provisions set forth by the State of Ohio relative to non-participating property owners of wind farm projects in Ohio show disregard for the citizens of these areas. These safe setback distances are based from inhabited residences of adjacent properties, but should be based only from the property lines and public roadways. Ohio property owners use all of their property for their activities, they do not always stay indoors. They should be able to enjoy every inch of their property without concern for the happiness and safety of themselves and their family. People should be able to farm, hunt, fish, cut-wood, hike, play, etc. anywhere on their property and feel safe. They also need to be able to develop their property now or in the future (like building a new home) how they wish without being close to neighboring wind turbines. The safety concerns regarding ice throw, blade shear, shadow flicker, noise, etc. are real. The happiness and safety rights of property owners should be foremost to that of wind farm developers. Wind turbine manufacturers safety manuals used by the wind company employees and workmen, should apply no less for non-participating property owners. They have not given their consent for the State of Ohio to use any part of their property in calculating wind turbine setbacks.

Among which are those of enjoying and defending life and liberty, Acquiring,


Possessing , and protecting property, and seeking and obtaining Happiness and
