# The Commission finds:

- (1) Each of the above-captioned applications was filed in accordance with Rule 4901:1-40-04(F), Ohio Administrative Code (O.A.C.), for certification as an Ohio renewable energy resource generating facility as defined in Section 4928.01, Revised Code.
- (2) In addition, Rule 4901:1-40-04(F)(2), O.A.C, provides for automatic approval of an application for certification as an eligible Ohio renewable energy resource generating facility, unless the Commission suspends the application within sixty days.
