On March 3, 2011, Black Fork Wind Energy, LLC filed an application with the Ohio Power Siting Board (OPSB) for a certificate to construct and operate a 200 megawatt (MW) Wind Energy Project in Crawford and Richland Counties, Ohio. Since that time, staff continues to review the application and carefully consider all potential impacts associated with the siting of this project.

Please be advised, a local public hearing in this matter will be held on Thursday, September 15, 2011, at 6:00 p.m., at the Shelby Senior High School, 109 West Smiley Avenue, Shelby, Ohio 44875. The adjudicatory hearing will commence on Monday, September 19, 2011, at 10:00 a.m., 11th floor, Hearing Room 11-D, at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, Columbus, Ohio 43215-3793.


