WILLIAM MASSEY**

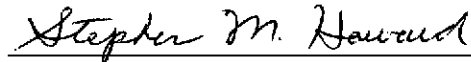

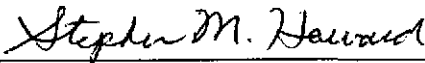

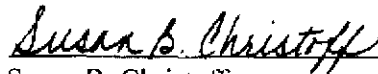
