In its Entry dated June 22, 2011, the Board directed that by September 5, 2011, the Applicant and Intervenor shall file a list of issue(s) citing specific section(s) of the Staff Report for which they may be interested in pursuing cross-examination of the Staff at the evidentiary hearing. Pursuant to the Entry dated August 30, 2011, the deadline for the issues list was extended to September 7, 2011.

The interest of Intervenor in this case largely relates to the requirements of OAC Rule 4906-17-08(E). This interest generally relates to traffic control issues, the potential impact on public roadway improvements and financial assurance obligations. Each of the Intervenor has statutory jurisdiction and responsibility over county and township roadways, bridges and other transportation facilities within the Project Area of the proposed Black Fork Wind Project in Richland and Crawford Counties.




