**REPLY COMMENTS OF
THE EAST OHIO GAS COMPANY D/B/A DOMINION EAST OHIO**

Pursuant to the Commission's September 7, 2011 Entry, The East Ohio Gas Company d/b/a Dominion East Ohio ("DEO") submits the following Reply Comments.

DEO concurs with the Comments submitted by Columbia Gas of Ohio, Inc. ("Columbia"), and Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively, "FirstEnergy"). Columbia and FirstEnergy proposed to completely delete any reference to the Office of the Ohio Consumers' Counsel ("OCC") in all Commission-mandated notice provisions. *See* Columbia Comments at 1-2; FirstEnergy Comments at 3-4.

These comments express the reality of OCC – its contact information is no longer necessary to provide to consumers. Any reference to OCC implies that OCC can handle utility complaints, leading to customer confusion. *See* Columbia Comments at 2; FirstEnergy Comments at 3. Customers will also be confused when calling OCC's customer call center telephone number listed in the proposed rules. The lengthy voice message received upon dialing that telephone number acknowledges that OCC is unable to respond to calls and refers callers to a variety of other resources. Continuing to include OCC's telephone number on customer bills and communications adds no value for customers. Finally, DEO agrees that deleting the

customer contact information in all notice provisions comports with the intent of R.C. 4911.021.

The Commission should adopt the rule revisions proposed by Columbia and FirstEnergy and eliminate OCC's contact information from Ohio Adm. Code 4901:1-13-06(C), 4901:1-13-09(B)(2)(d), 4901:1-13-09(C)(2)(e), 4901:1-13-11(B)(5), 4901:1-18-06(A)(5)(d) and 4901:1-29-11(B)(10).
