## **SUMMARY**

On August 1, 2011, Columbus Southern Power Company and Ohio Power Company (AEP) filed an application for approval to adjust their Economic Development Cost Recovery Rider (EDR). The EDR determines the amount a customer will pay by multiplying a customer's distribution charges by a percentage such that the utility timely recovers costs resulting from the delta revenues under the Commission-approved reasonable arrangements.

In this application the delta revenue results from reasonable arrangements approved by this Commission in Case No. 09-119-EL-AEC with Ormet Primary Aluminum Corporation (Ormet), Case No. 09-516-EL-AEC with Eramet Marietta, Inc. (Eramet), Case No. 08-884-El-AEC with Globe Metallurgical, Inc. (Globe), and Case No. 10-3066-EL-AEC with The Timken Company (Timken). This is the first EDR application that includes delta revenues resulting from the Globe and Timken reasonable arrangements.

In this application, AEP proposes to adjust the percentages to be applied to customer's distribution charges such that the proposed percentage for Columbus Southern Power Company (CSP) is 6.96141% and the proposed percentage for Ohio Power Company (OP) is 13.94508%. Currently, the percentages are 6.80493% for CSP and 7.53687% for OP. The proposed CSP EDR charges include delta revenues associated with Ormet and Eramet, and the proposed OP EDR charges include delta revenues associated with Ormet, Globe and Timken.

## STAFF REVIEW AND RECOMMENDATIONS

Staff has reviewed the application and supporting schedules and finds the proposed EDR charges are a result of delta revenues resulting from reasonable arrangements approved by the Commission and recommends approval of the proposed application in this case.
