STATEMENT INFORMING THE COMMISSION WHETHER  
THE ISSUES RAISED IN THE COMMENTS HAVE BEEN RESOLVED**

Pursuant to the Attorney Examiner's September 1, 2011 Entry, The East Ohio Gas Company d/b/a Dominion East Ohio ("DEO") provides this statement informing the Commission whether the issues raised in the Comments filed on September 26, 2011 have been resolved.

The major issue in this case has been resolved. DEO, Commission Staff and The Office of the Ohio Consumers' Counsel ("OCC") have agreed to the PIR Cost Recovery Charge of \$2.22 per customer per month for the GSS/ECTS rate class.


OCC raised an additional issue in its Comments concerning DEO's calculation of January through June 2011 bonus tax depreciation. After informal discussions, OCC agrees with DEO's calculation of January through June 2011 bonus tax depreciation.

The parties have reached an agreement in principle for resolution of the issues in this case and are in the process of memorializing their agreement in a Stipulation and Recommendation that will be submitted to the Commission, along with supporting testimony.


