MOTION FOR PERMISSION TO PRACTICE *PRO HAC VICE*

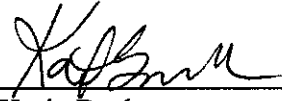

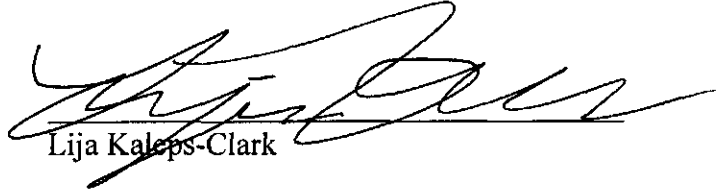
