


JOINT MOTION FOR CONTINUANCE AND
EXTENSION OF THE DEADLINE TO FILE STAFF TESTIMONY

In accordance with Finding (5) of the Administrative Law Judge's October 13, 2011 Entry, the City of Hamilton and American Municipal Power, Inc. ("Applicants") and OPSB Staff jointly move for a continuance of the adjudicatory hearing currently scheduled for October 25, 2011 and an extension of the OPSB Staff testimony deadline of October 20, 2011. 
