- 1 Q. PLEASE STATE YOUR NAME, TITLE, AND BUSINESS ADDRESS.
- 2 A. My name is David C. Rinebolt. My business address is 231 West Lima Street,
- Findlay, Ohio 45840. I am the Executive Director of Ohio Partners for Affordable
- 4 Energy (OPAE), and I appear in this case as a witness on its behalf.
- Q. PLEASE DESCRIBE YOUR BACKGROUND AND QUALIFICATIONS FOR
   YOUR TESTIMONY IN THIS PROCEEDING.
- A. My career has covered a broad spectrum of activities in the energy industry 8 9 including policy analysis at both the federal and state levels; design and management of energy efficiency and renewable energy deployment programs; 10 11 and, extensive involvement in utility regulatory systems at the state and federal tevel. I have worked with alternative fuel implementation and distributed 12 generation and have extensive knowledge of energy and environmental policy, 13 including renewable energy development and sustainability. My resume is 14 15 appended to this testimony as Exhibit DCR-1.

I have a Bachelor of Liberal Studies degree with concentrations in

Communications, English, Political Science, and Russian Literature from Bowling

Green State University (1978) and a Juris Doctor degree from the Columbus

School of Law at The Catholic University of America (1981). I have also received training in utility regulatory policy through the NARUC Summer Study Program at Michigan State University. I am the author of several works on biomass energy and a regular lecturer on regulatory policy at the National Community Action

Foundation Energy Leveraging Conference; Affordable Comfort; and the National 1 2 Energy and Utility Conference. I have also been a presenter at the National Association of Regulatory Utility Commissioners; the National Association of 3 State Utility Consumer Advocates; and, the Mid-America Regulatory Conference. 4 In 1994 I worked for the Department of Energy on assignment in the design and 5 deployment of the program that made up the Clinton Administration's Climate б 7 Change Action Plan, and was a presenter at the White House Conference on 8 Climate Change. 9 HAVE YOU PREVIOUSLY TESTIFIED BEFORE THE OHIO PUBLIC UTILITIES 10 Q. COMMISSION ("PUCO" or "Commission")? 11 12 A. No. 13 PLEASE DESCRIBE THE PURPOSE OF YOUR TESTIMONY. Q. 14 The purpose of my testimony is to demonstrate that the Stipulation: (1) is the 15 A. product of serious bargaining among capable, knowledgeable parties; (2) does 16 not violate any important regulatory principle or practice; (3) and, as a whole, will 17 benefit consumers and is in the public interest. 18 19 PLEASE GENERALLY DESCRIBE THE STIPULATION. 20 Q. The stipulation establishes the terms and conditions related to the Standard 21 A. Service Office (SSO) of Duke Energy Ohio from January, 2012 through May, 22 2015. The agreement also includes provisions related to the Significantly 23

Excessive Earnings Test (SEET); provides funding to improve the energy efficiency of various customer groups; contains provisions to encourage economic development in the Duke Energy Ohio service territory; and, establishes a process for development of the next SSO application. The stipulation also defines riders that will recover the costs of complying with Ohio's Advanced Energy Standard and other components of the SSO. DOES THE STIPULATION REPRESENT THE PRODUCT OF SERIOUS Q. BARGAINING AMOUNG CAPABLE, KNOWLEDGEABLE PARTIES? A. Yes. The parties and their counsel are regular participants in regulatory proceedings before the Commission and represent all customer classes affected by the stipulation, as well as certified Competitive Retail Electric Suppliers and organizations representing the interests of energy marketers. There were a significant number of negotiating sessions including all parties and additional bilateral discussions between the Company and individual parties. DOES THE STIPULATION VIOLATE ANY IMPORTANT REGULATORY Q. PRINCIPLE OR PRACTICE? No. Based on my understanding, the stipulation comports with all relevant and important principles and practice. It is consistent with the requirements of state regulatory principle and practice regarding the establishment of an SSO.

1	Q.	DOES THE STIPULATION REMELLI CONSOMERS AND IS IT IN THE LODGIC
2		INTEREST?
3	A.	The stipulation benefits consumers in a variety of ways. It allocates funding from
4		shareholders to meet pressing social and economic needs within the Company's
5		service territory. It will also utilize market forces to establish the price of the SSC
6		which, based on my analysis, will benefit consumers compared with the
7		alternative, which is consistent with the goal of the State of Ohio to utilize
8		competitive markets to establish generation prices. As such, the stipulation is in
9		the public interest.
10		
11	Q.	IS THE STIPULATION A JUST AND REASONABLE RESOLUTION OF THE
12		ISSUES?
13		Yes. The stipulation represents a balancing of the interests of the company, marketers,
14		and consumers and efficiently and effectively addresses the issues raised in this
15		proceeding. This outcome could only be the result of a negotiated resolution in this
16		matter. The agreement, in my opinion, will result in just and reasonable SSO rates
17		established by the use of market forces.
18	Q.	DOES THIS CONCLUDE YOUR TESTIMONY
19	A.	Yes.
