On October 21, 2011, CenturyLink filed tariff revisions with the Federal Communications Commission to add rates and regulations for Synchronous Optical Channel Service at operating speeds of OC48 and OC192 in the state of Ohio. In addition, Customer Premises Ports and Add/Drop Multiplexing (Central Office Ports) rate elements were revised to include additional levels ranging from 10 Mbps to 1 Gbps. This filing proposes to add an exception for Synchronous Optical Channel Service contained in P.U.C.O. No. 2 Access Service Tariff, Exception Section. This exception will exclude Ohio's intrastate jurisdiction from the Synchronous Optical Channel Service defined in CenturyLink Operating Companies Tariff F.C.C. No. 1 for OC192 for Channel Termination, Channel Mileage, Customer Node and SONET Regeneration rate elements and Customer Premises Ports and Add/Drop Multiplexing at levels ranging from 10 Mbps to 1 Gbps.
