### **MOTION FOR SUBPOENA**

Pursuant to Ohio Administrative Code ("OAC") Rule 4901-1-25, Stand Energy Corporation ("Stand") hereby moves the Public Utilities Commission of Ohio ("Commission") for the issuance of a subpoena to command Scott White, President of Interstate Gas Supply, Inc. ("IGS"), to appear and testify at the evidentiary hearing in the above-captioned proceeding, which is scheduled to commence on Monday, November 7, 2011 at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th floor. Room 11-C Columbus, Ohio 43215.

On September 13, 2011, and pursuant to the Attorney Examiner's Entry dated June 16, 2011, both Stand and OCC (co-complainants in the above-captioned proceeding) filed witness lists with the Commission disclosing Scott White as an individual who could be called as a witness in this proceeding. Mr. White is the President of IGS, and the person who, on behalf of IGS, signed the licensing agreement with NiSource allowing IGS to use the Columbia name and starburst logo—the same licensing agreement that precipitated the filing of this complaint case.

In accordance with the Commission's rules, specifically OAC Rule 4901-1-25(E), this subpoena is being issued at least five days prior to the commencement of the hearing. Further, OAC Rule 4901-1-25(F) states that "Any persons subpoenaed to appear at a commission hearing, other than a party or an officer, agent, or employee of a party, shall receive the same witness fees and

mileage expenses provided in civil actions in courts of record." (Emphasis added). Because Mr. White is the President of IGS, and thus an officer of the company, no witness fees or mileage expenses are enclosed.
