REGARDING THE BANKRUPTCY STAY


Infotelecom, LLC ("Infotelecom") hereby submits this Supplemental Authority
Regarding the Bankruptcy Automatic Stay.

On October 18, 2011, Infotelecom filed a petition for bankruptcy in Case No. 11-18945 (Bankr. N.D. Ohio). Shortly afterwards, Infotelecom filed a notice of bankruptcy and suggestion of stay in this proceeding. As the Commission is aware, this proceeding is one of several involving Infotelecom and related AT&T entities. Attached as **Exhibit 1** is a Scheduling Memorandum issued by the Michigan Public Service Commission in Case No. U-16858 on October 19, 2011 suspending that proceeding based on the bankruptcy filing by Infotelecom. Attached as **Exhibit 2** is Order No. 4 issued by the Texas Public Utility Commission in Docket No. 39700 on November 4, 2011 abating the proceeding based on the bankruptcy filing by Infotelecom. The Commission should likewise stay this proceeding pending the resolution of Infotelecom's bankruptcy proceeding.




