**REPLY OF THE NORTHEAST OHIO PUBLIC ENERGY COUNCIL TO
INTERSTATE GAS SUPPLY'S
MEMORANDUM CONTRA INTERLOCUTORY APPEAL**

On November 4, 2011, the Northeast Ohio Public Energy Council (“NOPEC”) filed an interlocutory appeal requesting an order reversing the November 2, 2011 Entry granting Interstate Gas Supply Inc's ("IGS") motion to quash the subpoena filed by NOPEC. At the end of the evidentiary hearing on November 7, 2011, NOPEC orally amended the interlocutory appeal to specifically request that the Attorney Examiner certify NOPEC’s interlocutory appeal to the Public Utilities Commission of Ohio (“Commission”). On November 14, 2011, IGS filed a Memorandum Contra NOPEC’s Application for Certification of Interlocutory Appeal (the “Memo Contra”).

Rather than spend time rehashing arguments already presented to this Commission, NOPEC simply incorporates by reference the arguments raised in its Interlocutory Appeal. For the reasons stated therein, NOPEC urges the Attorney Examiner to certify its interlocutory appeal to the Commission for review.
