ENTRY

The attorney examiner finds:

- (1) By entry issued November 18, 2011, the attorney examiner found that, unless otherwise ordered, certain documents subject to a public records request and identified in paragraph 19 of the October 19, 2011, supplemental joint motion for protective order¹ would be released in redacted form on November 25, 2011, following an opportunity for the parties to conduct an *in camera* review of the redacted documents.
- (2) On November 23, 2011, following an *in camera* review, counsel for Columbus Southern Power Company and Ohio Power Company (AEP-Ohio or the Companies) filed an interlocutory appeal of the attorney examiner's proposed release of the document identified as number 92 in redacted form. Among other things, AEP-Ohio argues that document 92 represents terms sheets that the Companies have consistently argued should be protected from release in any form under paragraph 18 of the October 19, 2011, supplemental joint motion for protective order.
- (3) AEP-Ohio's argument is that, essentially, the attorney examiner has denied the Companies' motion for protective order by directing the release of the document in redacted form. Therefore, an immediate interlocutory appeal to the Commission of the attorney examiner's ruling is warranted pursuant to Rule 4901-1-15(A), Ohio Administrative Code. Accordingly, document 92 shall be withheld from the identified documents subject to release on November 25, 2011. The remaining documents identified in the November 18, 2011, attorney examiner entry will be released on November 25, 2011, in redacted form.

It is, therefore,



ORDERED, That a copy of this entry be served upon all parties of record in these matters.


