Dear Mr. Lewis:

Thank you for contacting the Public Utilities Commission of Ohio (PUCO) regarding your concerns about FirstEnergy's Energy Efficiency Incentives Program. Chairman Snitchler has asked that I respond on behalf of the Commission.

In your letter you state that, fundamentally, FirstEnergy's Energy Efficiency Incentive Program has been administered poorly. Your concerns regarding the lack of sharing of information by FirstEnergy have been provided to Staff, and forwarded to the PUCO's Independent Program Evaluator, who is to assess the electric distribution utilities' implementation of those plans and to make recommendations to Staff.

Also, a copy of your letter will be filed in the cases captioned above along with a copy of this response at your request. (Please feel free to visit the PUCO's docketing information system to follow the progress of these cases at <http://dis.puc.state.oh.us/> and enter the case codes listed above in the Case Lookup field.)

You should know the PUCO takes your concerns seriously, as we stand to balance the concerns of consumers with those of the utilities which operate under our authority. In this case, FirstEnergy did inform Staff after they became overwhelmed with the number and size of commercial lighting rebate applications. Additionally, FirstEnergy requested Staff approval to shift funds from other programs to this commercial/industrial lighting program, in order to be able to continue to fund projects under the program. While the current rebate level may not fully pay for anyone's lighting installations, the rebate will, nonetheless, defray a significant amount of lighting project costs.

First Energy responded to our query regarding your applications, and I am enclosing their reply.
