ENTRY NUNC PRO TUNC

The Commission finds:

- (1) Columbus Southern Power Company and Ohio Power Company (jointly, Applicants or AEP-Ohio) are electric light companies as defined by Section 4905.03(A)(3), Revised Code, and public utilities as defined by Section 4905.02, Revised Code. Applicants are, therefore, subject to the jurisdiction of this Commission pursuant to Sections 4905.04, 4905.05, and 4905.06, Revised Code.
- (2) On February 28, 2011, AEP-Ohio filed applications seeking an increase in electric distribution rates, approval of tariff modifications, and approval of changes to certain accounting methods.

- (3) On December 14, 2011, the Commission issued an Opinion and Order adopting a stipulation and recommendation filed in these proceedings and granting AEP-Ohio's applications to the extent provided in the Opinion and Order.
- (4) The first full paragraph on page 10 of the December 14, 2011, Opinion and Order, contains a sentence stating that "[s]econd, unless otherwise ordered by the Commission, AEP-Ohio's residential distribution rates will be adjusted, on a revenue neutral basis, to rates which are consistent with the rate design recommended by Staff in the Staff Reports and which will produce the annual revenue requirement agreed to in the Stipulation." This sentence on page 10 should be revised to include the effective date and should read as follows: "Second, unless otherwise ordered by the Commission, AEP-Ohio's residential distribution rates will be adjusted, effective January 1, 2015, on a revenue neutral basis, to rates which are consistent with the rate design recommended by Staff in the Staff Reports and which will produce the annual revenue requirement agreed to in the Stipulation."
- (5) Section IV of the December 14, 2011, Opinion and Order, entitled "Effective Date and Tariffs," on page 11, incorrectly states that "[t]he new tariffs will become effective for all services rendered on and after the effective dates of the tariffs." This sentence in Section IV should read as follows: "The new tariffs will become effective for all bills rendered on and after the effective dates of the tariffs."
- (6) Additionally, the fifth ordering paragraph on page 14 of the December 14, 2011, Opinion and Order, incorrectly states that the revised tariffs shall be effective for services rendered on or after such effective date. The fifth ordering paragraph should read as follows:

ORDERED, That the effective date of the revised tariffs shall be a date not earlier than the date of this Opinion and Order, the date upon which four complete copies of final tariffs are filed with the Commission, and the date on which the proposed customer notice is filed with the Commission. The revised tariffs shall be effective for bills rendered on or after such effective date.

It is, therefore,

ORDERED, That the Opinion and Order of December 14, 2011, be amended, *nunc pro tunc*, to provide for the revised sentences and ordering paragraph as set forth above. It is, further,

ORDERED, That a copy of this Entry be served on all parties of record.
