CONSUMMATION NOTICE AND REQUEST TO TRANSFER CERTIFICATE

Dear Ms. Jenkins:

On behalf of DSLnet Communications, LLC ("DSLnet") and DIECA Communications, Inc. ("DIECA") (together, the "Applicants"), the Applicants hereby inform the Public Utilities Commission of Ohio ("Commission") that on December 31, 2011, DSLnet completed a transaction with its affiliate DIECA whereby DSLnet merged with and into DIECA with DIECA surviving the merger. Pursuant to the above-referenced application and supplement to the proceeding filed October 31, 2011, DIECA hereby requests that the Commission transfer to DIECA the authorization held by DSLnet to provide local telecommunications, granted in Case No. 99-150-TP-ACE. DIECA intends to retain its existing authority to provide interexchange telecommunications granted in Case No. 99-718-CT-ACE.

As a result of the merger, DSLnet no longer offers services in Ohio and therefore no longer requires its authorization. Because DSLnet does not serve any intrastate telecommunications customers in Ohio, the company respectfully submits that the final transfer of its authorization, as approved by the Commission in the above-referenced proceeding, is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity. As the company will no longer hold any authorizations in Ohio following the transfer of its authority to DIECA, DSLnet requests that the Commission remove DSLnet from its list of carriers on the Commission's website, and to undertake any other administrative actions necessary to complete the requested transfer.
