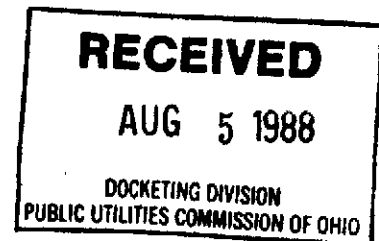

The requirement to submit Section 61.38 supporting data with this filing is waived pursuant to Special Permission No. 85-153.


