
On February 3, 2012, The Toledo Edison Company filed the schedules, bill impacts and tariff pages to support the Delivery Capital Recovery Rider (DCR) charges commencing April 1, 2012 in the above referenced docket. Ohio Edison Company made a similar filing in the docket in Case No. 12-522-EL-RDR on February 3, 2012. On February 28, 2012 Ohio Edison Company filed an update to its prior February 3, 2012 filing in Case No. 12-522-EL-RDR ("Update Filing"). Certain changes in Ohio Edison Company's February 28, 2012 Update Filing also appear in schedules included in the February 3, 2012 filing in the above referenced docket for The Toledo Edison Company, though these changes have no impact on the revenue requirements or associated rates included in the above referenced docket for The Toledo Edison Company. These changes are noted below.

- (1) Q2 2012 Revenue Requirements Summary (page 1)  
OE Lines 1 and 2 were updated in the 2/28/2012 Update Filing.
- (2) Actual 12/31/2011 Rate Base and Revenue Requirements – DCR Revenue Requirement Calculation (page 2)  
The OE ADIT balance in Line 14 Column B was updated in the 2/28/2012 Update Filing. This updated amount impacts the resulting OE Rate Base, and therefore the calculated revenue requirement on this schedule.
- (3) Actual 12/31/2011 Rate Base and Revenue Requirements – ADIT Balances (page 11)  
Line 1 for OE was updated in the 2/28/2012 Update Filing. This updated amount impacts the resulting Grand Total ADIT Balance listed on this schedule, as well.
- (4) 2Q 2012 Rider DCR – Rate Design (pages 52-55)

In Section I, OE Annual Revenue Requirement Based on Actual 12/31/2011 Rate Base (Line 2) was updated in the 2/28/2012 Update Filing. This updated amount in Section I impacts the calculations in the subsequent sections.

Details on the revision to the Ohio Edison filing on pages 1-2, 11, and 52 -55 can be found in the February 28,2012 Update Filing in the docket in Case No. 12-522-EL-RDR.
