### STATEMENT OF COLUMBIA GAS OF OHIO, INC. RELATING TO STAFF AND INTERVENOR COMMENTS

By Entry dated March 7, 2012, the Public Utilities Commission of Ohio ("Commission") directed Columbia Gas of Ohio, Inc. ("Columbia") to file a statement, informing the Commission whether the issues raised in the comments of Staff and intervenors have been resolved.
