Dear Ms. McNeal:

Pursuant to the February 29 and March 20, 2012, entries in this matter, Buckeye Telesystem, Inc.'s ("Buckeye") FCC Tariff No. 1 Terminating Switched Access and Transport Rates are almost identical to the Buckeye Terminating Switched Access and Transport Rates found in PUCO Tariff No. 3. The lone difference is that the FCC Transport Facility (per minute per mile) in the AT&T service area is rated at \$0.000013 compared to the PUCO Rate of \$0.000014. Instead of reducing the rate to 50% of the difference, Buckeye proposes to reduce the PUCO Transport Facility (per minute per mile) in the AT&T service area from \$0.000014 down to \$0.000013 effective July 1, 2012. There are no further calculations. No further reductions would need to be made in 2013.

Buckeye respectfully requests that the Commission approve the attached 2<sup>nd</sup> Revised Page No. 103-A.1 to become effective on July 1, 2012.
