

**AMENDED MOTION FOR PROTECTIVE ORDER**

Pursuant to Ohio Administrative Code Chapter 4901-1-02(E), Q LINK WIRELESS LLC ("Q LINK" or the "Company") hereby submits this Amended Motion for Protective Order respectfully requesting that the Public Utilities Commission of Ohio ("Commission") enter an Order to protect the confidentiality of its facilities information, which was filed as Exhibit N to its Application for Designation as a Low-Income Competitive Eligible Telecommunications Carrier in Ohio on January 30, 2012 ("Application"). The original Motion for Protective Order was submitted concurrently with the Company's Application. Q LINK filed a withdrawal, without prejudice, of its Application on February 21, 2012. However, the Company maintains that Exhibit N, its facilities information, still warrants confidential protection and treatment by the Commission.

Q LINK is a privately held Limited Liability Company and its facilities information is not part of the public record in any jurisdiction. Further, Q LINK submits that its facilities information constitutes trade secrets under Ohio law, the disclosure of such information would be detrimental to Q LINK in the competitive telecommunications market as competitors may obtain sensitive information regarding the Company's assets, facilities, facilities' locations, operations, and business model. Non-disclosure of its facilities information is consistent with Title 49 of the Ohio Code.


Accordingly, Q LINK requests that the Commission treat Exhibit N as confidential and not disclose the facilities information or any information contained therein to any person not responsible for reviewing its application.
