<MSG>Duke Energy Generation Rider In my March utility bill I was charged a Generation Rider. However, AEP is the Energy provider and Duke is only the distributor. I contacted the PUC and was told that this was passed as an adder last November and was allowed to be added to customers who were not using Duke as the generator. The AEP rate is \$.0589/kwh. Duke which is higher is \$.0597/kwh. When one applies the generation adder my new rate is \$.0659/kwh. In effect what has happened is Duke is able to raise the rate for using an alternative supplier to above the Duke rate. Thus defeating the competitive program. You are supposedly a strong free market advocate. This adder which is being allowed under your leadership is defeating the system. This needs to be rescinded immediately and allow competition prevail.</MSG>
