**MOTION TO APPEAR *PRO HAC VICE*
OF RICHARD LEHFELDT**

Pursuant to Rule 4901-1-08(B) of the Ohio Administrative Code and Gov. Bar R. XII(2), Robert L. Kinder, Jr., an attorney licensed to practice in the State of Ohio, respectfully moves that Richard Lehfeltdt be admitted *pro hac vice* to practice before the Public Utilities Commission of Ohio (the “Commission”) for the purpose of representing CPV Power Development, Inc. (“CPV”) in the above-captioned proceeding. In support thereof, Mr. Kinder states as follows:

1. Pursuant to Gov. Bar R. XII(2)(A)(1), Mr. Lehfeltdt neither resides in nor is regularly employed at an office in Ohio.
2. Pursuant to Gov. Bar R. XII(2)(A)(2), Mr. Lehfeltdt has neither taken and failed the Ohio bar examination, nor been denied admission without examination, nor had an application for admission in Ohio denied on character and fitness grounds pursuant to Gov. Bar R. I within the last five years.
3. Pursuant to Gov. Bar R. XII(2)(A)(3), Mr. Lehfeltdt has applied for registration with the Supreme Court Office of Attorney Services, paid an annual registration fee of \$100.00, and been issued a Certificate of *Pro Hac Vice* Registration, attached hereto, by the Supreme Court of Ohio Office of Attorney Services.

4. Pursuant to Gov. Bar R. XII(2)(A)(5) and XII(2)(A)(6)(d), Mr. Lehfeltdt has not been granted permission to appear *pro hac vice* in more than three proceedings before Ohio tribunals in the current calendar year.
5. Pursuant to Gov. Bar R. XII(2)(A)(6)(a), Mr. Lehfeltdt's residential address is 26 Adalia Avenue, Tampa, FL 33606. He is employed by the law firm Dickstein Shapiro LLP, located at 1825 Eye St. NW, Washington, DC 20006.
6. Pursuant to Gov. Bar R. XII(2)(A)(6)(b), Mr. Lehfeltdt was on December 13, 1982 admitted to practice law in the District of Columbia (#367021).
7. Pursuant to Gov. Bar R. XII(2)(A)(6)(c), and as he attests in the Affidavit of Out-Of-State Attorney, attached hereto, Mr. Lehfeltdt has not been disbarred, is not currently under suspension, and has not resigned with discipline pending in any jurisdiction in which he has ever been admitted.
8. Pursuant to Gov. Bar R. XII(2)(A)(6)(e), I, Robert L. Kinder, Jr. (#0076662), an active Ohio attorney in good standing, hereby agree to associate with Richard Lehfeltdt in this proceeding.

Also attached is a Certificate of Service on all known parties and attorneys of record. Furthermore, Mr. Lehfeltdt understands that, if this Motion is granted, he must file a Notice of Permission to Appear *Pro Hac Vice* and a copy of the Order granting permission with the Office of Attorney Services within thirty days of the Order.

WHEREFORE, Robert L. Kinder respectfully requests that Richard Lehfeldt be permitted to practice before the Commission in the above-captioned proceeding.

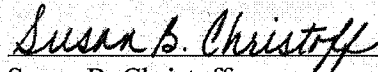

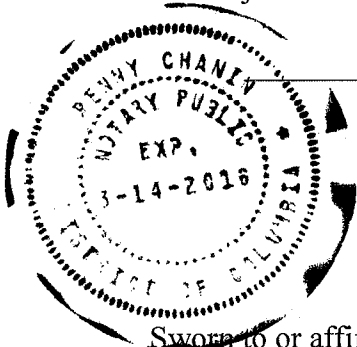
