McClure Exchange: Switched access rates applied to the intrastate jurisdiction shall remain at the levels existing on December 31, 1997. (T)

Edge Out Exchanges (as set forth in Section 12 of the Company's PUCO Tariff No. 6): Pursuant to the Commission's Opinion and Order issued August 22, 2007 in Case No. 06-1344-TP-ORD, the Company shall, over a 3-year period, reduce its intrastate access rates annually by one-third of the difference between the rates charged in the McClure Exchange (as "frozen" in 1997) and the current switched access rates set forth in NECA Tariff FCC No. 5. Therefore, the intrastate switched access rates in the Company's Edge Out exchanges shall be calculated as follows:

- Effective September 21, 2008:  $\frac{2}{3}$ (McClure 1997 "frozen" rates minus current NECA switched access rates) plus then-current NECA switched access rates.
- Effective September 21, 2009:  $\frac{1}{3}$ (McClure 1997 "frozen" rates minus NECA switched access rates effective September 21, 2008) plus NECA switched access rates effective September 21, 2008.
- Effective September 21, 2010: Equal to then-current NECA switched access rates.
