## DIRECT TESTIMONY OF ROGER R. GEIGER ON BEHALF OF NFIB/OHIO

#### 1 I. INTRODUCTION.

- 2 Q. Please state your name and business address..

- 4 Q. By whom are you employed and in what capacity?
- I am employed as Vice President and Executive Director of the Ohio chapter of
- 6 the National Federation of Independent Business ("NFIB/Ohio").
- 7 Q. Please describe your educational background.
- 8 A. I graduated from the Franciscan University of Steubenville, in Steubenville, Ohio,
- 9 with a Bachelors of Arts in Political Science and History in 1983, and received a Masters

of Public Administration from The Ohio State University in 1986.

### 11 Q. What is NFIB?

NFIB is a nonprofit, nonpartisan organization dedicated to representing the voice of small and independent businesses. NFIB/Ohio currently has over 24,000 members statewide, ranging from large corporations to small sole-proprietorships; however, the vast majority of NFIB/Ohio members employ twenty-five or fewer and have annual gross revenues of less than one million dollars. In my over two decades with NFIB/Ohio, I have worked with thousands of small-business owners acting as their advocate in order to help make their voice heard at the Statehouse and throughout the State of Ohio.

#### Why are you offering testimony in this proceeding?

In the months following the Opinion and Order of the Public Utilities Commission of Ohio ("PUCO" or "Commission") in December 2011, we received a large volume of calls, as well as many emails, from our members in the AEP-Ohio service territory. They were upset over the recent rate changes resulting in substantial increases to their electricity costs—at least one of which claimed an increase was as high as nearly three hundred percent.

### Q. Please explain the purpose of your testimony.

The purpose of my testimony is to relay the concerns of our members—and those of the hundreds of thousands of small-business owners throughout the state—to the Commission. In the last few months, NFIB/Ohio has received dozens of calls, emails, and questions from our membership in the AEP-Ohio service territory. These are real business owners, facing significant increases in their AEP-Ohio monthly bills that, frankly, threaten the jobs of hardworking Ohioans. And that's not something NFIB/Ohio

takes lightly.

It is our position as an organization—and the position of our over 24,000 members—that a competitive marketplace can function only when free market principles are allowed to work. And though Ohio may not yet have a truly competitive marketplace as of today, such a deregulated arena was the stated goal of the legislature over a decade ago. NFIB/Ohio endorsed that plan nearly thirteen years ago, and continues to support a rate structure that will help achieve competitive electricity service here in Ohio.

I offer the perspective of our members as to the effects of AEP-Ohio's rates on the businesses that they own, operate and serve. I am not a lawyer; I am not an economist; and I am not an analyst with a Ph.D. What I am is a leading advocate for small-business owners throughout Ohio to convey to the Commission exactly how AEP-Ohio's rates influence job creation and the economy here in Ohio. That is not something that can be measured by technical lingo, complex formulas, or the opinions of highly paid analysts. That is something measured in the everyday consequences of this potential increase upon the members of NFIB/Ohio that I am representing, and upon them as Ohio's leading job creators and those they employ.

#### II. IMPACT ON SMALL BUSINESSES.

Q. What has been the impact on your members of the AEP-Ohio rates currently under reassessment by the Commission?

In a word, harmful. My staff and I have spoken with dozens of NFIB/Ohio members throughout the AEP-Ohio service territory, and all of them have serious concerns that these significant and disparate rate increases will have detrimental impact on their business. With market-based electric rates at historic lows, the Commission's

recent decision seemed to have the opposite effect, disproportionately driving up costs on small-business owners. At a time when Ohio is rebuilding from a nationwide economic recession, it seemed like a bad time to be increasing costs to the creators of nearly two out of every three jobs in the State. NFIB/Ohio believes that small businesses are the backbone of our economy and their interests are just as important as their larger counterparts. As such, NFIB/Ohio wholeheartedly welcomed the Commission's February 2012 Entry on the reconsideration of the AEP-Ohio rate plan. Despite the Commission's reconsideration, however, the disparate impact felt by Ohio's small businesses has already taken its toll on the Ohio job market.

## Q. Can you provide any examples of this impact felt by small business?

A.

Certainly. Doug Leuthold, an NFIB member and the owner of a small business in Bucyrus, Ohio, Advanced Fiber Technology which employs of nineteen individuals. His company saw its month-to-month electric bill climb from \$5,549.25 for 331,800 kilowatt/hours ("KWH") to \$13,546.21 for 282,600 KWH—an over two-hundred and eighty percent increase per KWH, despite having less usage. The total bill over that period went from \$25,192.31 to \$30,292.86—an increase of twenty percent. Given his company's yearly average usage, this represents a roughly \$124,000 per year increase. Having to compete in a truly competitive marketplace, Advanced Fiber Technology is unable to adjust its prices without effectively pricing itself completely out of reach of likely customers. As a result, Mr. Leuthold has postponed filling three positions at his business, pending resolution by the Commission of this rate proceeding. A letter received from Mr. Leuthold (RRG 001) and the AEP-Ohio invoices referred to above (RRG 002-RRG 005) are appended to my Direct Testimony.

Then there is Kelly Moore, an NFIB member in Zanesville, Ohio, and CFO of GKM Auto Parts, Inc., a business that employs of twenty-three individuals. At her four locations, her business has experienced increases in its electricity invoices ranging from a low of twenty-one percent to a high of thirty-six percent. As a result, Mrs. Moore has been forced to look at possibly moving her business or eliminating a part-time summer position to absorb the increase without passing it along to her customers. Once again, Mrs. Moore operates her business in a competitive marketplace, so she runs the risk of losing customers if she decides to raise her prices in order to pass these costs along to her customers. Attached to my testimony is a letter received by NFIB/Ohio from Mrs. Moore (RRG 006-RRG 007), along with the referenced AEP-Ohio invoices (RRG 008-015).

Thirdly, Jerry Miller is an NFIB member who owns a small manufacturing business near Mansfield, Ohio. In December of 2011, his electricity usage cost him \$0.097/KWH. In February of 2012, that figure rose to \$0.123/KWH, representing a twenty-seven percent increase. See, (RRG 016-RRG 017) attached to my testimony. While many believe Ohio has opportunities to once again become a leader in manufacturing, Mr. Miller, and other small business owners like him throughout the state, cannot recognize those opportunities with such increases in his costs of doing business.

## Q. Are these the only examples of the impacts felt by your members?

No. These examples are just the tip of the iceberg. My staff and I have heard from numerous other small-business owners struggling to manage their energy costs.

But, as you see from their attached letters and billing information, they represent the drastic effects these rate increases have had on small-businesses in the AEP-Ohio territory. And while these rates have since been withdrawn, pending resolution by this

Commission, our members are facing an uncertainty about their ability to not only maintain and create jobs, but also to stay in business altogether. Simply put, the escalating costs of doing business threaten the continued existence and vitality of our small-business owner members.

#### III. COMPETITIVE RATES FOSTER FREE MARKET PHILOSOPHIES.

A.

Q. Please explain NFIB/Ohio's position as it relates to a competitive electric marketplace.

NFIB/Ohio has supported making Ohio a competitive state for electric service since the late 1990's. It was our position then, and it is our position now, that free markets foster true competition and that government intervention should be limited to only what is necessary. Unfortunately, AEP-Ohio's actions since then call into question whether or not they have embraced the General Assembly's plan. In a competitive marketplace, costs are not seamlessly passed onto customers. Rather, NFIB/Ohio members, and small-business owners throughout the state, do not have the luxury of adjusting the market to their costs—they must adjust their costs to the market. That involves cutting costs and eliminating inefficiencies if that individual business wants to survive in the marketplace.

I fully and readily acknowledge that electric service in Ohio, as it stands today, is not truly as competitive as the general free market and, therefore, the Commission plays a key role in ensuring that rates are set in such a manner so as to not discriminate against individual classes or from electric service provider to another service provider. But in a world where small businesses survive on razor-thin margins and do so without any guarantee of profitability, it becomes frustrating that AEP-Ohio seeks the certainty of an

annual double-digit ROE during the transition period to an open, competitive marketplace. No small business in this state operates under such financial security or certainty. Instead, each business owner must become more efficient and discover new innovations to become more profitable. By allowing AEP-Ohio to lean on the crutch of financial certainty of a double digit guaranteed rate of return, the Commission is, in effect, discouraging that same innovation and those same efficiencies from AEP-Ohio.

## Q. What is your recommendation for the Commission in this Proceeding?

A. Aggressively priced rates are the best way to ensure lower prices for customers and guarantee that AEP-Ohio is continuing its shift to a truly open and competitive marketplace. Business, no matter how big or small, must adapt its operation to the market, not the other way around. Of course, NFIB/Ohio recognizes that prices within each individual market do fluctuate. To that end, should the Commission deem that an increase in electric service rates is necessary, we ask that such an increase be spread equally among all users, whether residential, commercial or industrial. Clearly, small-business owners cannot be the sole group asked to bear the burden of any rate increase without serious and detrimental effects on job creation and retention within the AEP-Ohio service territory. Small business creates roughly two out of every three jobs in this state and Ohio cannot recover from the economic downturn of the past few years if small-business owners continue to see the costs of doing business rise disproportionate to their larger counterparts.

## Q. Do you have any concluding remarks?

Α.

I would again like to underscore just how extraordinary NFIB/Ohio's intervention is in this case. While we have been an advocate for small business throughout the state

for decades, prior to the Capacity Charge proceeding, we had never sought to intervene as a party to a case before the Commission. Our unprecedented involvement in these two cases emphasizes the importance of the Commission's decision to Ohio's job creators and every individual they employ. It is exactly why we're asking that the Commission allow free market forces to work, and ensure that AEP-Ohio's rates be set at a competitive level in the electric service market for small commercial users and business owners.

Dear Mr. Larger:

Advanced Fiber Technology is a small business in Bucyrus, Ohio that converts wastepaper into insulation and for fiber additives in various other products such as roof coatings, asphalt paving, etc. We are served by AEP Ohio and AEP Retail as our CRES.

The AEP Ohio portion (Distribution) of our 23 January 2012 invoice went from \$0.0167 per KwH in 19 December 2011 to \$0.0479 per Kwh or a multiplier of 2.9X greater. The difference is \$0.0312 per KwH. We purchase slightly over 4 million Kwh per year in our manufacturing operation. Using round numbers the annual impact on Advanced Fiber Technology is a minimum additional \$124,000 per year. Our average annual manufacturing employee cost including all benefits, payroll taxes, etc. is slightly under \$40,000 so this impact is the same as slightly more than 3 employees.

Further analysis, since there is no detail on the monthly invoice to provide any clarity as to the nature of the increases or cost elements, attributed a major portion of the increase to the Demand Charge which went from \$1.98 per KW up to \$3.76 per KW or a 1.9X increase. I understand Demand Charge increase was from a prior PUCO approved action that coincided with ESP implementation date. Our 2011 monthly demand averaged 1,007 KW resulting in an annual increase of \$21,500 of the \$124,000 with the balance resulting from various new riders which compounds the Demand Charge impact.

The overall increase to our company is 2.9X per Kwh which is extremely excessive in my opinion. Think of this as \$4 gasoline going almost to \$12 per gallon. Not a very good thought.

We currently have 19 employees and would normally be staffed at 22. Thus the impact of the proposed increase has already had a negative impact on business and our community as I cancelled filling the additional 3 positions pending resolution of the proposed rate hike.

I encourage the Ohio PUCO to fully reject any new riders or changes to riders.



#### AEP Ohio Messages

AEP's distribution rate Case No.
11-351-EL-AIR, resulted in a revenue increase and a new Distribution Asset Recovery Rider which was approved to collect the cost of previous distribution system improvements and expenses.

The Public Utilities Commission of Ohio adopted two agreements that will determine electric generation and distribution rates for AEP-Ohio customers beginning Jenuary 1, 2012. AEP's Electric Security Plan (ESP), in Case No. 11-340-EL-SSO, resulted in a morger of Columbus Southern Power and Ohio Power and a transition to a market-based generation rate in 2015.

In Case No. 11-281-Et-FAC, AEP Implemented its Fuel Adjustment Clause (FAC) which is the mechanism through which AEP Ohio recovers generation fuel costs and related expenses.

Pursuant to state law, the Universal Service Fund rider rate has been adjusted effective with this bill.

GKM Auto Parts, Inc. is a small business which currently employs 23 full-time and part-time employees at 4 retail locations in Muskingum and Coshocton counties. We sell automotive aftermarket parts to the do-it-yourself mechanic and to professional garages, industrial facilities, construction companies, mining operations and various other commercial users. We are a customer of AEP Ohio.

Our annual usage for 2011 was just over 149,000 KWH. The recent significant increase in the per KWH charge for Generation Service, Transmission Service, Distribution Service, and Customer Charge fees resulted in a damaging increase for our business. The spreadsheet below shows the billing period, KWH usage, and total amount of the bill for December 2010/January 2011 in the second column for each account. The third column shows what last year's bill would have been if it had been calculated using this year's per KWH rates (as of 1/11/12). The fourth column shows the percentage of increase.

With this increase, electricity will cost GKM Auto Parts an additional \$4100 per year. A part time summer position will be eliminated to absorb this increase without passing it along to our customers.

Our customers grumble about pain at the pump and the increase in the price of petroleum products. A quart of oil on 1/15/12 retailed for only 10% or \$0.30 more than it did on 1/15/11, making that increase seem like a bargain compared to the increase inflicted on small business for electric usage.

We respectfully ask Ohio PUCO to reject any changes to the recent riders, and implementation of new riders, which may impede small business development and/or expansion.




