COMMENTS OF OHIO POWER COMPANY
TO THE PUBLIC UTILITIES COMMISSION OF OHIO'S
APRIL 16, 2012 ENTRY ON COMMISSION'S ALTERNATIVE
ENERGY PORTFOLIO STANDARD

BACKGROUND

On April 16, 2012, the Staff of the Commission filed a draft of the Alternative Energy Portfolio Standard (AEPS) report in docket No 12-11-EL-ACP. The draft AEPS report references the Alternative Energy Resource Market Assessment by the National Association of Regulatory Utility Commissioners (NARUC), issued September 2011. This NARUC assessment report was also filed under the same docket.

On April 16, 2012, the Commission requested that any interested parties are invited to file any comments regarding the proposed AEPS report by May 21, 2012. Ohio Power Company (dba AEP Ohio) hereby submits its comments.

COMMENTS

AEP Ohio has only two comments regarding the AEPS report filed by staff. They are:

1. AEP Ohio would like to see information regarding the topic of actual broker costs brought into the report regarding RECs and S-RECs. Adding this additional type information would help expand on how the markets were

functioning at that time.

2. AEP Ohio also recommends that further clarification be added around what is

shown as "Certified" projects and whether they show associated megawatts or

installed megawatts. For example, the South Point Biomass Generation Plant

of 177 megawatts of wood waste is currently certified, but is not yet

constructed and it appears that the values are captured in the megawatts

shown. Additionally, there are many installations that are installed but not

certified, it is not clear if those values are captured in the numbers shown.

Further clarification as to what is being displayed in the numbers would be

helpful.
