They had a number of increases in passed years which amounted to around a 23% for 3 years I did go to the meeting in Lima Ohio on May 3, 2012 but did not speak my concerns over the raises as there were a number of people there, mostly business voices their concerns & disapproval of the raises. I am just a regular customer with A.E.P. of which they stated if you use 1000 KWH your bill would only increase 6.22 a month. Use more than 1000 KWH a month but if use only 1000. - 6.22 x 12 months is 74.64 a yr. I understand they don't think that it is much of a increase but I am 73 yrs of age & on a fixed income like a lot of people are and any increase puts a bigger burden on you with every thing else going on in this country. I also switched in Dec. 2011 to First Energy Solutions for my supplier and I am paying a lower rate than A.E.P. I understand this could be in jeopardy to. My rate is locked in till Sept. of 2013 ???

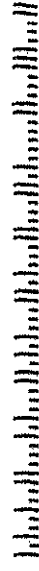

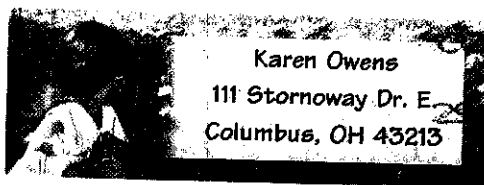

the condo fees, malfeasance of duty.

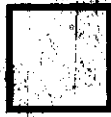
