**MOTION FOR PERMISSION TO APPEAR *PRO HAC VICE* OF DAVID M. STAHL**

Pursuant to Rule 4901-1-08(B) of the Ohio Administrative Code, now comes M. 
- f) Mr. Stahl has made the required filing at the Ohio Supreme Court and a copy of the Court's affidavit is attached to this motion.

WHEREFORE, M. Howard Petricoff respectfully requests that David M. Stahl be permitted to practice before the Commission in the above styled proceeding.





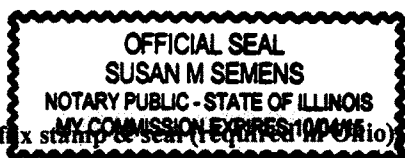
