DEMAND SIDE MANAGEMENT RIDER

APPLICABILITY:

Applicable to all customers.

DESCRIPTION:

An additional charge per month per account, regardless of gas consumed, to recover costs associated with Company's assistance to homebuilders to encourage homebuilders to build homes to a higher standard than Ohio's building energy code, but only where such builders have available to them an offer from another natural gas company to provide such assistance at the same location or proposed location. The Company may recover under this Rider only those costs incurred to meet, but not to exceed, the assistance offered by another natural gas company. This Rider shall be calculated annually pursuant to a notice filed no later than May 31 of each year based on nine months of actual data and three months of estimated data for the reporting year. The filing shall be updated by no later than August 31 of the same year to reflect the use of actual reporting year data. Such adjustments to the Rider will become effective with bills rendered on November 1 of each year.
