Dominion East Ohio Gas Company ("DEO") filed a Construction Notice for authority to planning to replace 1,581 feet of 26 inch high pressure ("HP") bare steel pipe with 1,581 feet of 30 inch HP coated steel pipe. This construction will run in the center median of Warrensville Center Road from north of Okalona Road to just south of the South Euclid city border. <sup>1</sup>

Dominion East Ohio will submit payment of \$2,000 in accordance with Ohio Administrative Code Rule 4906-6-11(I) so that the Construction Notice will be considered on an expedited basis. If you have any questions please call at the number listed above.
