The Applicant hereby modifies its intrastate access service tariff to clarify that the End Office Local Switching Rate of \$.13971, as filed in Case No. 12-1352-TP-ATA, is the Terminating Rate; the Originating End Office Local Switching Rate of \$.23280 is now hereby added to the tariff. Similarly, the Information Surcharge Rate of \$.0513, per 100 MOU, as filed in Case No. 12-1352-TP-ATA is the Terminating Rate; the Originating Rate of \$.0532 is now hereby added to the tariff. The Originating Rates for End Office Local Switching and Information Surcharge that are hereby added to the tariff are current rates that were unaffected by the access rate reductions filed in Case No. 12-1352-TP-ATA.
