ACCESS SERVICE TARIFF

The rates, charges and conditions for the provision of Intrastate Carrier Access Service are as specified in TARIFF F.C.C. No. 5, No. 3 and No. 4 (filed with the Federal Communications Commission by the National Exchange Carrier Association), as each now exists and as each may be revised, added to, or supplemented. The effectiveness of Section No. 4, End User Access Service, as applied to intrastate customers, has been suspended by the Public Utilities Commission of Ohio. The rates, terms, and conditions for Intrastate Carrier Common Line Access Service are set forth herein.
