I request my comments be filed in the case for FirstEnergy's new ESP3 or Case # 12-1230-EL-SSO:

The proposed bill that FE submitted reflects an expected bill increase of between 25% to 30% for all electric customers beginning in 2014.

How can this happen??? While FE did not modify the credits they are giving us for being All Electric, what they are trying to do is raise the Distribution Rates for all customers, but it always hits the All Electric Customers the most because we use the most electricity, and such increases are based on a charge per kilowatt used. Specifically, FE is asking for an additional \$405 million in Distribution Costs

(rider DCR).

I request these rate increases not be allowed. These rates will severely impact my standard of living. I am retired and now that the All Electric Promise was ignored and my rates are going up substantially I CANNOT afford ANOTHER huge rate increase. Secondly these rates are going to make it very difficult to sell my home as most people will NOT want an all-electric home at these rates. I am counting on the value of my home to help support me in my retirement. Additionally, these rates are going to make North East Ohio unattractive to residents who will flee to more favorable areas where they can heat and cool their homes more affordably. Lastly, these rates will severely impact industry in Ohio driving out even more industry to other areas and states.

Please PUCO is SUPPOSED to help protect the consumers in Ohio and frankly with the denial of the All Electric Promise I am begging you to deny First Energy's request to pile on even more rate increases on the backs of all electric customers!

First Energy Solutions has evidently submitted a 300-page plus document asking for yet another rate increase for electricity. Now home owners are not purchasing agents and can't be expected to read all the lengthy legalese and understand the "small type." But the Public Utilities Commission of Ohio can and I expect you to do that and exercise your authority to reject their request to raise our bill by another 30 percent.

We're retired, but let's just forget all that fixed income business. (But we are paying our bills with dollars earned in 1985--a 1985 dollar will buy us 49 cents worth of product today.)

From what I understand, First Energy is asking a major increase in distribution charges. A cost that is not competitively bid. Am I right?

From what I read, First Energy in their lengthy request doesn't even mention how the price increase will effect their customers. C'mon. Customers represent 50% of the buy-sell equation: Supplier, 50 %. Customer, 50%.

Look at that proposed distribution cost increase long and hard. Is it as fair to us, as customers, as it is to the Electric Company? To me, that's the question here. You're the referee.
