It is apparent from page 11 of First Energy's initial post-hearing brief filed on June 22, 2012 that the predominant cause of the expected increase in prices is because of the increase in capacity prices in 2015-2016 as a result of the generator retirements in response to new U.S. EPA requirements.

The situation seems obvious. First Energy failed to earlier plan or respond in a way that could have minimized the capacity price increases. First there is the failure to move sooner and faster to bid

maximum energy efficiency resources into the PJM BRA. Then there is the failure to promote distributed generation (renewables, CHP) to provide reactive power to mitigate the need for transmission upgrades where this need generation could have also been bid into the PJM BRA to mitigate capacity price increases.

The Commission also bears responsibility for developing a late response to these opportunities.

The ESP extension request should not be approved without stronger provisions related to the above.
