In this filing, CenturyLink Operating Companies Tariff F.C.C. No. 1 modified the Identification and Rating of VoIP-PSTN Traffic section to be in compliance with the FCC's Second Order of Reconsideration in WC Docket No. 10-90, etc., FCC Release No. 12-47 (April 25, 2012) which temporarily modified the compensation of originating VoIP-PSTN Traffic on a prospective basis.
