MEMORANDUM IN SUPPORT

Subsequent to the filing of comments, VEDO discovered an accounting error that affects the calculation of the distribution replacement rider ("DRR") for which approval is sought in this proceeding. VEDO has provided detailed information to Staff and OCC describing this error and its effect on the DRR calculation. Additional time is sought in order to permit consideration of this information for resolution in this proceeding. Accordingly, VEDO respectfully requests that the remaining dates on the procedural schedule be extended for twelve (12) days until August 20, 2012 for the filing of a stipulation and until August 21, 2012 for the hearing.
