**AMENDMENT TO APPLICATION OF WATERVILLE GAS & OIL COMPANY FOR  
APPROVAL OF LONG TERM FINANCING ARRANGEMENT**

Waterville Gas & Oil Company submits the following amendment to paragraph 4 of its Application filed in this docket on May 22, 2012. After the existing text of paragraph 4, the following text is added:

“The principal amount of the extended Promissory Note will depend on the date of approval of the facility by the Commission and issuance of the note, but will not exceed the current principal balance on the facility as of the date of the issuance of the extended note. As an example, if Commission approval is granted and the note is issued in August, the extended Promissory Note would be for a principal amount of \$481,066.56. The principal amount would be reduced by \$5,466.67 for each subsequent monthly principal payment prior to issuance.”

This is the only Amendment to the Application filed on May 22, 2012.
