ENTRY

The Commission finds:

- (1) In its finding and order in Case No. 11-4910-AU-ORD (11-4910) dated November 29, 2011, the Commission adopted changes to various rules throughout the Ohio Administrative Code. Specifically, the Commission required regulated utilities to make certain changes involving contact information for the Office of the Ohio Consumers' Counsel to implement Section 4911.021, Revised Code.
- (2) On March 16, 2012, and March 26, 2012, Water and Sewer LLC (W&S) and Woodbran Realty Corporation (Woodbran) filed motions seeking a waiver of the requirement to file revised bill formats within 30 days of the February 23, 2012, entry in this docket.
- (3) In its motion, W&S seeks permission to defer filing its revised bill format until the company files its compliance tariff sheets pursuant to the Commission's order in its pending rate increase application in Case No. 11-4509-ST-AIR. W&S states that changes will have to be made to the bill format to reflect the substitution of the tariff sheet containing the new rates for the tariff sheet containing the current rates. Thus, the interests of efficiency and economy would be best served by permitting W&S to defer the filing of the revised bill format until the compliance tariff sheets are filed pursuant to the opinion and order in the rate case.
- (4) In support of its request for a waiver, Woodbran submits that, due to the age and substantial revisions necessary to the current tariff, the company has been engaged in discussions with Commission Staff regarding withdrawing it current tariff, P.U.C.O. No. 4, and replacing it with a new tariff, P.U.C.O. No. 5, in the near future. As a result, Woodbran would anticipate

filing its revised bill format as part of its application for approval of its new tariff, P.U.C.O. No. 5.

- (5) No memorandum contra were filed opposing these waivers.
- (6) The Commission finds that the motions for waiver filed by W&S and Woodbran are well-made and should be approved.

It is, therefore,

ORDERED, That, in accordance with finding (6), the motions for waiver filed by W&S and Woodbran are approved. It is, further,

ORDERED, That a copy of this entry be served upon Water and Sewer LLC, Woodbran Realty Corporation, and their respective counsel.
