Examiner Parrot:

Ohio Power Company (dba AEP Ohio) filed its Application initiating this proceeding on March 30, 2012.

AEP Ohio stated in its Application (at 15) that, once FERC approves full, legal corporate separation, the Company, pursuant to the Corporate Separation Plan, will (1) update the list of affiliates and (2) update the corporate organizational chart that is included within the Cost Allocation Manual (CAM) to add AEP Generation, remove CSP in recognition of its merger into AEP Ohio and record any other accumulated changes in corporate structure. As a related matter, Staff in its comments (at 2) reiterated the need for an update of AEP Ohio's corporate organizational chart to reflect the legal entities that are related to American Electric Power Company, Inc. and Staff specifically suggested that the updated organizational chart reflect reportable segments similar to the information AEP provides to the Securities and Exchange Commission in its 10K filings. Through its reply comments, the Company reinforced (at 4) its commitment to provide the updated information as soon as it is available. Enclosed is the first follow-up item, an updated list of affiliates that is current as of August 3, 2012. As to the second follow-up item, consistent with the Company's reply comments and the Staff's recommendation, AEP Ohio agrees to update the CAM (and notify Staff of the update) after approval of corporate separation by the FERC and contemporaneous with the corporate separation closing.

Prairie Wind Transmission, LLC	A joint venture between Electric Transmission America, LLC (ETA) and Westar Energy, Inc. to build approximately 110 miles of 765kV transmission line in southern Kansas. The total AEP ownership of the joint venture is effectively 25%.
Price River Coal Company, Inc.	An inactive subsidiary of Indiana Michigan Power Company. The company was formerly engaged in mining coal on Utah properties owned or leased by Blackhawk Coal Company.
Public Service Company of Oklahoma	Public utility operating company subsidiary engaged in the generation and purchase of electric power, and the subsequent sale, transmission and distribution of that power to approximately 527,000 retail customers in eastern and southwestern Oklahoma.
