## **ENTRY**

The Attorney Examiner finds:

- (1) Section 119.032, Revised Code, requires all state agencies to conduct a review, every five years, of their rules and to determine whether to continue their rules without change, amend their rules, or rescind their rules. The following rules are now scheduled to be reviewed: Chapter 4901:2-6, Ohio Administrative Code (O.A.C.), address hazardous materials carriers registration. The rules in Chapter 4901:2-8, O.A.C., address highway routing of non-radioactive hazardous materials. The rules in Chapter 4901:2-21, O.A.C., address registration of intrastate motor carriers. The rules in Chapter 4901:3-1, O.A.C., are the general provisions for railroads.
- (2) On July 19, 2012, the attorney examiner issued an entry scheduling a rule review workshop for the rules in Chapters 4901:2-6, 4901:2-8, 4901:2-21, and 4901:3-1, O.A.C., for August 24, 2012, at 10:00 a.m., at the offices of the Commission, in Hearing Room 11-B. The entry further stated that the workshop would be webcast to allow broader access.
- (3) Due to unforeseen circumstances regarding internet connectivity at the offices of the Commission, the workshop scheduled for August 24, 2012, will no longer be webcast. Further, the location of the workshop must be moved from Hearing Room 11-B to Hearing Room 11-C.

It is, therefore,

ORDERED, That, in accordance with finding (3), a workshop be scheduled for August 24, 2012, in Hearing Room 11-C. It is, further,
