Dear Ms. McNeal:

On October 30, 2009, Duke Energy Ohio, Inc. submitted an application for certification as an eligible Ohio renewable energy resource generating facility. The Public Utilities Commission of Ohio (Commission) approved the application on September 8, 2010. Since that date there have been some changes to the details included in the application. Duke Energy Ohio hereby submits notice of such changes as required by the Commission in its Finding and Order of September 8, 2010 at paragraph 11.

The Application that was submitted on October 30, 2009 should be amended as follows:

Section B - The Applicant is Duke Energy Ohio, Inc. Communication concerning the application should be provided to Timothy J. Thiemann, Vice President, Midwest Generation Operations. Mr. Thiemann's phone is 513-287-2642 and his facsimile number is 513-287-2695. His email is tim.thiemann@duke-energy.com

Section D - The legal name of a contact person for the generation facility is David Beck, General Manager of Non-regulated Fossil Station. Mr. Beck's phone is 513-287-2640. His email is david.beck@duke-energy.com

Section E - Should be amended to be the same as section B.

Section G - Certification Criteria 2: Qualified Resource or Technology, listed the following:

"Biomass materials including but not limited to raw wood chips, herbaceous crops, wood pellets and agricultural waste will be co-fired with coal in proportions of 1% up to 100% of total heat supplied."

The above list should be updated to include **bio-diesel** fuel. Please note this correction for the case file.

Section J.1 through J.3 – Should be changed to reflect that Duke Energy Ohio is operating within the geographic area of PJM Interconnection, Inc., and is not within Midwest ISO.

Section K - Should be changed to designate the GATS tracking system only, and not MRETS.
