MEMORANDUM IN SUPPORT

On September 30, 2008, USG&E was granted Ohio Competitive Retail Natural Gas Marketer Certificate No. 08-139(1). On August 30, 2010, USG&E filed a Renewal Certification Application and Ohio Competitive Retail Natural Gas Marketer Certificate No. 08-139(2) was granted on October 5, 2010 effective through October 1, 2012.

O.A.C. Rule 4901:1-27-09 provides that a renewal application be filed between 120 and 30 days before expiration of a retail natural gas supplier's certificate. Due an administrative oversight, USG&E's current renewal application was not filed by the September 1, 2012 deadline but filed on September 18, 2012. Because the Rule contemplates at least 30 days for the Commission to review a renewal application, USG&E requests an extension of the expiration date of its current certificate through October 18, 2012. O.A.C. Rule 4901:1-27-02(B) allows the Commission to alter, amend, or waive "in whole or in part" any of the rules in Chapter 4901:1-27. As with its original 2008 application and its 2010 renewal application, USG&E's 2012 renewal application meets all the requirements of O.A.C. Rule 4901:1-27-06(C) and the Commission should reach the merits of the 2012 renewal application by granting this Motion.
