Thank you for contacting the Ohio Power Siting Board (OPSB) regarding First Energy's proposed Bruce Mansfield-Glenwillow 345 kV Transmission Line Project.

As you know, on June 1, 2012, FirstEnergy filed a pre-application notification letter for this case with the OPSB and subsequently scheduled four public informational meetings in regards to the transmission line and related substation. These preliminary meetings, required by OPSB rules, are held before a developer like FirstEnergy submits a project application to the OPSB. In this case, FirstEnergy met the OPSB's public informational meeting requirement by providing public notice seven to 14 days prior to the meetings.

To date, First Energy has not submitted an application for these projects. Once the applications are submitted and determined to be complete, the OPSB staff will begin its formal investigation. The investigation will address several of your areas of concern including the consideration of any preferred or alternate routes.

Again, thank you for your concerns about this process. I have attached an Ohio Power Siting Board process flowchart for your reference. Additional information about the projects will be available once First Energy submits their applications.
