**NOTICE OF WITHDRAWAL BY THE UNIVERSITY OF CINCINNATI**

The University of Cincinnati ("UC") hereby notifies the Commission and Duke Energy Ohio that it is withdrawing its Motion for Intervention and Comments in Opposition to the Application which were filed on February 13, 2012. UC's interests have been satisfied given the Commission's approval of the Joint Application of Duke Energy Ohio, Inc. and the University of Cincinnati for approval of a reasonable arrangement for transporting natural gas in Case No. 12-2171-GA-AEC. The reasonable arrangement obviates the University's need for an off peak, interruptible service designed to support electric generation.

WHEREFORE, UC respectfully withdraws its February 13, 2012 Motion for Intervention and Comments in Opposition to the Application.
